PV Sindhu defeats Japan's Okuhara in straight games to become the 1st Indian to clinch a gold in Badminton World Championships

V Sindhu on Sunday scripted history as she became the first Indian to win badminton World Championships gold by beating arch-rival Nozomi Okuhara of Japan in a lop-sided summit clash here on Sunday.

The Olympic silver-medallist Indian won 21-7 21-7 in the final that lasted just 38

Two years after being robbed off the gold by Okuhara in an epic 110-minute final at Glasgow that was considered as one of the greatest battles in badminton history, Sindhu finally exorcised the ghost of that heart-wrenching loss with a completely dominating win over the same opponent.

'Last time, I lost in the final, before that also I lost in the final, so it is a very important win for me. I want to thank the crowd for supporting me. I won it for my country and I am very proud being an Indian," Sindhu said after the match.

"A big thanks to my coach Kim and Gopi sir and my supporting staff and I dedicate this win to my mom, it's her birthday today," she added.

With her fifth medal of the World Championships, the 24-year-old Indian was already one of the greatest ever women's singles players in the showpiece event's history. She had won a bronze each in the 2013 and 2014 editions
